## LeaderSpark results are in!

As you all know, Albany County LWV was one of the 5 pilot programs for Leader Spark. Over the past 6 weeks, we have been having HS students from many different districts in the Capital Region meet together and learn about various aspects of Leadership. Our topics included Qualities and Styles of Leadership, Working with Groups, Planning Projects, Dealing with Conflict and Presenting Yourself.

Now for our winners:

We had a total of 12 regular participants, ranging from one eighth grader to one senior. We had 4 males and 8 females representing schools in Albany, Rensselaer and Columbia County. Our students came from Albany High, Guilderland, Voorheesville, South Colonie, Ravena-Coeymans-Selkirk and Albany Academy for Girls, as well as Columbia High in East Greenbush and Ichabod Crane in Kinderhook. We were allowed to choose 3 to go to the Students Inside Albany Conference, but actually 4 of our participants will be attending. The criteria for selection for the Conference involved good attendance and participation, interest in learning about how government works, and a brief written piece (not necessarily a formal essay) stating reasons why they should be allowed to attend the conference. At first about 8 of the students indicated they wished to attend the conference, and I thought I would have to make a difficult choice. I enlisted the Board's help in case we had to narrow our choice down to three. As it turned out, the Conference is scheduled for the week that AP exams are starting, and many of the students decided they would not be able to attend the conference if chosen.

Our three winners are:

From Albany County, Shayna Bentley, a 10th grader from Guilderland; Samuel Broadaway, an 11th grader from Albany High and Miralem Prijic, an 11th grader from South Colonie.

We were fortunate in that the Columbia County League, who had difficulties with their essay contest this year, was looking for a student to send. Since Claudine Murphy, a 9th grader at Ichabod Crane, lives in Columbia County, that League agreed to sponsor her (thank you to Kathy M. White).

We are all very proud of this fine group of students who gave me a lot of great feedback which will prove valuable for the next time we run this ambitious but worthy program.

Our sessions ended recently, and I'd like to take this opportunity to publicly thank all of you who helped out with the programs. It is very difficult to do something "the first time", and I could not have done it alone. I'd like to thank Ruth Dinowitz, Marggie Skinner, Angie Sherman, Ray Blanchard, Pearlle Stricklin, Bonnie Beard, Bob Thierrault and Barbara Bartoletti. They all gave up a few precious hours of their time on at least one Sunday afternoon during March or early April, and a few of them came and helped out at many. I'd like to thank Girls' Inc. for allowing us to use their facility at 25 Western Ave. I'd like to also thank Senator Neil Breslin, who was our guest speaker at the closing award celebration on Sunday, April 9th. Also, words of gratitude to Rob Marchiony, Joan Elliott and Stephanie Lopez at State League for their support. There are many more who deserve thanks, for example our sponsors and individuals who gave me contact names, but a more complete report will be issued in the Annual Report.

## Exciting Debates Coming Up this Fall

Our Albany League has volunteered to work with the LWVNYS and a local media partner on a couple of interesting debates for the statewide primaries this Fall!

State League is partnering with the local League chapters to bring together a series of debates for those running for statewide office. We're very excited to have been asked to co-sponsor the debates for the Democratic Attorney General candidate's primary, and for the Democratic candidates for Governor. Democratic primary for AG **is a highly visible race with many Democratic challengers, including (at this point):** Richard Brodsky (State Assemblyman and attorney); Andrew Cuomo (former US Housing Secretary, attorney and '02 Governor candidate); Mark Green (former NYC Public Advocate, attorney and '01 NYC Mayor nominee); Charlie King (attorney, Democratic activist and '98/'02 Lt. Governor candidate); Sean Patrick Maloney (attorney, former Clinton White House aide & Gay Rights activist); and Denise O'Donnell (former US Attorney & former social worker). Democratic challengers for Governor are (again, at this point) Elliot Spitzer (the current Attorney General of NYS) and Thomas Suozzi (current Nassau County Executive).

The LWV of NYS and the local Leagues each have tasks to accomplish to bring these debates about. Tasks for the Albany County League include securing a local broadcast media partner and site. We hope that we can partner with WMHT, and discussions with them are underway. We also have been encouraged to recruit professionals to moderate the debates, and to determine a format that, while exquisitely fair in true League fashion, might be a little more interesting and exciting than our more traditional formats. The Albany League would work to establish the themes, issues and questions that would be put to the candidates, help select a studio audience, and would provide any necessary volunteer effort (timekeepers, etc.). So stay tuned! If you like to volunteer for Voter Service activities, this could be a really exciting one for you!

## NYS League Has a Transportation Specialist!

The March State Board Report announced the appointment of *Gladys Gifford*, of the Buffalo-Niagara League, to the position of off-board specialist for Transportation issues. The following is reprinted from her first SBR. We look forward to further issues as we all try to find measures to conserve gasoline and enhance realistic transportation alternatives in NYS.

"One task I will undertake is to analyze the LWWNYS Impact on Issues to suggest an organized approach to transportation based on the various parts of our positions on Natural Resources, Social Policy, and State Finances which apply.

Meanwhile, the NYS Department of Transportation is currently in the process of finalizing its long-range plan for transportation. The deadline for public comment was February 24, 2006. The document is called "Transportation Strategies for a New Age: New York's Transportation Plan for 2030." It was formulated by an advisory panel that held hearings in 2004 to gain citizen input. The plan is available at the NYSDOT website: [www.dot.state.ny.us](http://www.dot.state.ny.us). To view it, select "NYS Transportation Plan" located at the bottom of the lower left list in the NYSDOT home page and click on "Draft Transportation Plan 2005-2030."

The NYSDOT has issued a long-range plan in previous years, but it was largely ignored by the transportation planners. The current plan may be a positive document, if implemented. Therefore, when every League makes transportation policy a part of their activism, we can ensure that the NYSDOT and the Governor will take this long-range plan seriously."

### **Some Background Information on the LWVUS Energy position (under Natural Resources)**

The League advocates a national energy policy emphasizing increased fuel-efficiency standards for automobiles, opposition to oil drilling in environmentally sensitive areas including the Arctic National Wildlife Refuge (ANWR) and support for government action in the development and use of energy conservation and renewable energy sources.

In the 108<sup>th</sup> Congress, the Senate voted twice not to open ANWR to destructive oil drilling. The House, however, included drilling in its version of the Energy Bill. The League also opposed and lobbied against the Energy Bill in the 108<sup>th</sup> Congress because it would have undermined existing clean air protections, made global warming worse and failed to provide for needed energy conservation measures. Currently, there has been a renewed effort to obtain drilling rights in the ANWR by proposing it as part of a budget resolution for the 2007 fiscal year. The LWVUS opposes this back door move. ## **NATIONAL BOARD RECOMMENDATIONS FOR ACTION AT 2006 LWV NATIONAL CONVENTION**

Board recommends retaining all current LWVUS positions

Board recommends a three-year study of immigration policy

Board recommends concurrence with the LWV Illinois Death Penalty Abolition Position

Board recommends adoption of the proposed FY 06-07 budget that includes a \$2.50 PMP increase

Board recommends an additional \$ .50 PMP increase for FY 07-08 to assist with the needed funding for the proposed immigration study

Board recommends adoption of two proposed bylaws amendments- a) changing Article II, sec. 1. Purposes: The purposes of the LWVUS are to promote political responsibility through informed and active participation **[of citizens]** in government and to act on selected governmental issues. and b) sec. 2. Types of Membership a. Voting Members. Citizens at least 18 years of age who join the League shall be voting members of local Leagues, State Leagues and of the LWVUS; (1) individuals who live within an area of a local League may join that League or any other local League; (2) those who reside outside the area of any local League may join a local League or shall be state members-at-large; (3) **[those who make a lump-sum life membership payment to the LWVUS shall be paid life members and]** those who have been members of the League for 50 years or more shall be honorary life members excused from the payment of dues. (Proposed changes will eliminate material within brackets)

The first change reflects a League commitment to promote participation in government of all, not just citizens and the membership change recognizes that there has not been a “lump-sum life membership” option for several years; for some reason it was not removed from the by-laws.

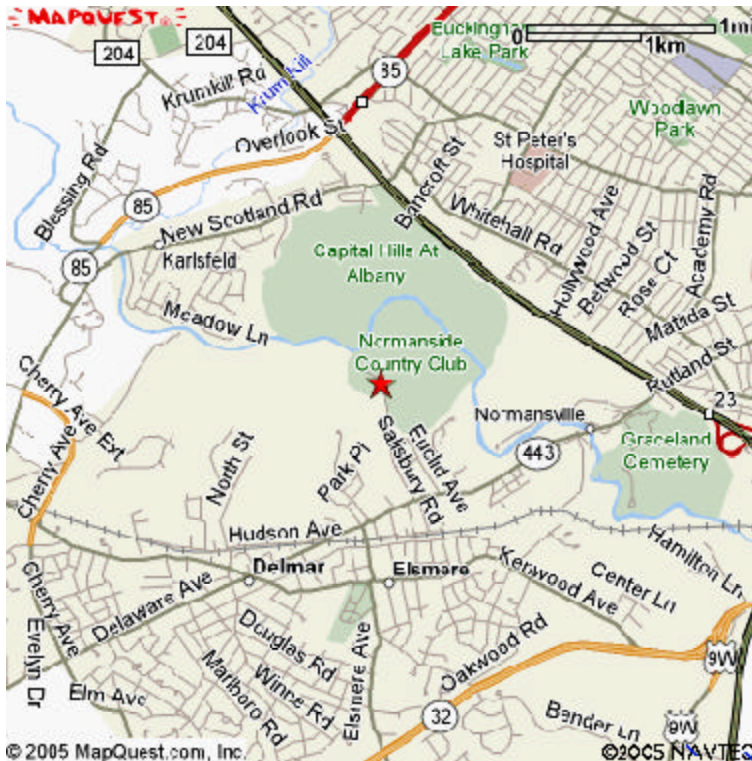
